### Option 1: **INTERAC**

This preferred method is the fastest way to receive your shoe tag(s). Pay to:

**1st Step:** When paying by **INTERAC**, PROVIDE ONLY YOUR NAME(S) and MEMBERSHIP TYPE(S) within the **INTERAC** message box. **INTERAC** cautions: Never include full personal info inside the message box. Email addresses often do not identify the exact name of the sender, so if you fail to provide your name in the box, we may have no way of confirming the sender's identity, delaying application processing.

**2nd Step:** Immediately after completing **INTERAC** payment, fill out this application form, then scan and email it to yorkwestontennisclub@outlook.com. Also, be sure to attach your scanned and signed Covid-19 waiver form. Once we have received both **INTERAC** payment and the rest of your personal info in the email, your 2022 shoe tag will be mailed out.

**Assumption of Risk and Waiver of Liability Relating to Coronavirus/Covid-19**

This waiver & declaration must be completed prior to or upon visiting York-Weston Tennis Club and before participating in any activity.

The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is known to spread mainly by contact from person to person. Consequently, local, provincial and federal governmental authorities recommend various measures and prohibit a variety of behaviors, in order to reduce the spread of the virus.

York-Weston Tennis Club and its members commit themselves to comply with the requirements and recommendations of Ontario National, Provincial and local Public health and other governmental authorities, and to put in place and adopt all necessary measures to that effect. However, York-Weston Tennis Club cannot guarantee that you (or your child, if participant is a minor/ or the person you are the tutor or legal guardian of) will not become infected with COVID-19. Further, attending the Activities could increase your (or your child, if participant is a minor/ or the person you are the tutor or legal guardian of) risk of contracting COVID-19, despite all preventative measures put in place.

By signing this document:

1. I acknowledge the highly contagious nature of COVID-19 and I voluntarily assume the risk that I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) could be exposed or infected by COVID-19 by participating in York-Weston Tennis Club's activities. If I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) experience, or if anyone in my household experiences any cold or flu-like symptoms after submitting this declaration, I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) will not attend any of York-Weston Tennis Club's activities, programs or services until at least 14 days have passed since those symptoms were last experienced.

I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of), nor has any member of my household travelled to or had a lay-over in any country outside Canada, or in any Province outside of Ontario, in the past 14 days. If I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) travel, or if anyone in my household travels, outside the Province of Ontario after submitting this declaration, I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) will not attend any of York-Weston Tennis Club’s activities, programs or services until at least 14 days have passed since the date of return.

I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) agree to the requirements and recommendations of National, Provincial and local Public health and other governmental authorities and to those special safety regulations put in place by York-Weston Tennis Club as it pertains the Covid-19 Coronavirus and to adopt all necessary measures to those effects.

I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of) agree that, by filling out and signing this waiver and agreeing to the terms and conditions set out in it, I am giving up my legal rights to sue York-Weston Tennis Club and its officers and directors, in the event that I (or my child, if participant is a minor/ or the person I am the tutor or legal guardian of), contracts the Covid-19 Coronavirus.

This document will remain in effect until York-Weston Tennis Club, as per the direction of the national, provincial and local government and health officials, determines that the acknowledgments in this declaration are no longer required.

This document is in addition to and does not replace all other York-Weston Tennis Club waivers.
